

## **Miltenyi Biotec's MACS® Cell Separation Hero Days 2026.**

### **Official Rules**

This MACS Cell Separation Hero Days promotion, referred to herein as the "Promotion," is organized and conducted by Miltenyi Biotec B.V. & Co. KG, with registered address at Friedrich-Ebert-Strasse 68, 51429 Bergisch Gladbach, Germany, ("Miltenyi"). Miltenyi will grant a total of twenty (20) vouchers – and ten (10) vouchers per event - for visits to Bergisch Gladbach, Germany, between (1) 18.05.2026 to 22.05.2026 ("May Event") and (2) 07.09.2026 to 11.09.2026 ("September Event") respectively, among participants in this Promotion, subject to these official rules ("Rules").

#### **1. ELIGIBILITY**

No purchase of Miltenyi's products or services is necessary to enter or win. A purchase will not increase your chances of winning. This Promotion is open only to participants that

- are PhD students in the fields of life science research;
- are legal residents of the European Union, the UK, Switzerland, Norway, Singapore, South Korea, Japan, North America, Australia or China;
- are 18 years or older as of the date of entry;

This Promotion is open to individuals only. No team entries and no corporate or institutional entries are permitted. Employees (and their immediate families) of Miltenyi, its affiliates, service providers and professional advisors connected with this Promotion are not eligible to enter.

- Between January 15, 2026, at 00:01 a.m. CET and March 15, 2026, at 11:59 p.m. CET: participants may select to apply for the May Event, the September Event, or both.

- Between March 16, 2026, at 00:01 a.m. CET and June 15, 2026, at 11:59 p.m. CET: participants may apply only for the September Event.

To participate individuals must:

#### **4. WINNER SELECTION AND NOTIFICATION**

For each event, ten (10) winners will be chosen at random by Miltenyi Biotec employees. This decision will be final.

Each winner must respond within five (5) business days of notification or forfeit the voucher, which may then be awarded to an alternate winner.

After the winners are selected, Miltenyi will provide a Declaration of Eligibility and Publicity Release form. Further instructions for claiming the Voucher will be sent by email.

To claim the voucher, each winner must provide the following documents via email or post:

- a. proof of travel documents (passport);
- b. travel insurance cover for the duration of the activity;
- c. a signed Declaration of Eligibility and Publicity Release;

Documents for May Event winners must be submitted by April 15, 2026. Documents for September Event winners must be submitted by July 15, 2026.
